



Application for Research Scholarship Housing for Research Students

By applying for a research scholarship – housing for research students, the student applying declares and commits to the following:

All information in these guidelines applies to both masculine and feminine genders.

1. I confirm that I am registered/have registered as a student at Ben-Gurion University of the Negev ("the University").
2. Since I am applying for a scholarship that I will receive in monthly payments, I declare and commit to the following:
 - a) I am aware that the scholarship applied for is intended to allow me to invest my time and energy in research, to help me successfully complete my studies.
 - b) I am aware that as a scholarship student I am required to dedicate most of my time to study and research, and that my attendance is required on the University's campus as laid out by the department and my advisor and will be taken into account in order to promote my research in a timely fashion.
 - c) I am aware that any break in studies at the University, before the studies are completed, for any reason including non-completion of academic assignments wholly or partly, or inappropriate behavior – will result in a cease of scholarship payments.
 - d) I am obligated to update the Dean of Students of any change in my academic status immediately and not any later than a week after the change.
 - e) I am aware that if it is possible for me to continue living in student housing after the cease of scholarship payments – I will be requested to pay the full cost, not including the scholarship.
 - f) I hereby agree to give to the concessionaire operating the research student housing at the University a copy of this application and any other information pertaining to the scholarship application or the scholarship payments made to me and/or any other information pertaining to the scholarship and my right to live in research student housing and I waive my right to make any complaint or pursue a lawsuit relating to the passing of information as said between by virtue of the law for privacy protection 1981 or virtue of any other law.
 - g) I hereby agree that I will aid the University in everything requested relating to fundraising and scholarship funding, including writing a letter to a donor if so requested. Due to this, I will allow the University to pass on details of the said scholarship and my studies, as part of its fundraising activities.

I waive my right to make any complaint or pursue a lawsuit relating to the passing of information as said between by virtue of the law for privacy protection 1981 or virtue of any other law.

- h) I am aware that if I gave the University incorrect details or that I did not report any change in the essential details I gave, I will be obligated to repay the University the amount I will receive as a scholarship and any right to request additional and/or other scholarships will be revoked, without diminishing the right of the University to take significant steps against me as it sees fit.
- i) I hereby agree that if I have a debt to the University due to a scholarship overpayment to me and/or a payment which is against the regulations, and which I am asked to repay, I confirm that I will pay my debts, as part of my tuition fees, in accordance with the accepted practice at the University regarding tuition fee debt.
- j) I am aware that the scholarship is tax-exempt if it meets the pertinent income tax regulations. I am also aware that a tax debt is personal and that I am solely responsible.
- k) I am aware that for as long as I receive a scholarship, it is not paid for work and there is no employee-employer relationship or entitlement to any other worker rights of any kind.

I am aware that these regulations also relate to housing grants and that I should be updated about changes taking place from time to time, and that I am obligated to follow them.
