# C. Courses

Encountering the 'other' (ESO) project: Encountering the 'other' in conflict relationship in the context of the Israeli Palestinian Conflict – a yearlong seminar to experience and explore the encounter with the other in a conflict relationship, in the context of the Israel Palestinian conflict including social identities, power relations in the structures and culture, and collective narratives. (2013-2014 and 2014-2015)

Transitional Justice: A yearlong course about Transitional Justice and its possible adaption for the context of Arab and Jewish communities in the Negev. The course integrates theoretical approaches to the subject of transitional justice with the specific

issues of conflict resolution, reconciliation, justice, and with action research in both Bedouin-Arab and Jewish communities in the South. (2015-2016 – current)
